In inviting a reference to the subject cited above it is to say that "Scholarship to the Children of PwDs pursuing Higher Education after 10th Standard" is an ongoing scheme to give educational scholarship to the Children of Persons with Disabilities (Father or Mother) having minimum 40% disabilities. Under this scheme the applications are invited from the eligible students to award scholarship @ Rs.350 per month for a maximum of 10 months and reimbursement of tuition fees, college exam fees, hostel charges and purchase of books & learning materials in an academic year subject to maximum Rs.50,000/- annually. The details of eligibility criteria of the scheme are indicated below:

1. The applicant must be bona fide resident of Odisha.
2. The applicant should be regular student of recognized educational institution after class 10th standard.
3. The applicant shall have family income of not more than Rs. 2,40,000/- per annum.
4. The applicant is not receiving any financial assistance from state Govt. /Central Govt. under any other scheme

You are therefore, requested to sponsor applications of all eligible students/ Children of Person with Disabilities to the respective BSSO Section in the Blocks/ ULBs of Rayagada District by 31st Jan. 2022 for sanction of scholarship.
