### ELIGIBILITY/ TERMS AND CONDITIONS FOR THE POST OF TGTs

1. The posts of TGTs can be filled up on part time contractual basis.
2. Contractual appointments are made till the end of the session or till the regular teacher will join whichever is earlier.
3. Teacher engaged on contractual basis, would have no claim or right for appointment on a regular basis nor will they be a part of the cadre of teachers of OAVS.
4. The payment will be on pro-rata basis as decided by OAVS.

### THE FOLLOWING MUST BE ENSURED

1. The teacher should possess the required educational qualification prescribed for direct requirement to the post.
2. Minimum and maximum age limit shall be 21 and 65 years respectively.
3. He/She must be engaged till such time the regular teacher joins or the end of academic session, whichever is earlier.
4. Candidature of a contractual teacher who have served in an OAVS in a year may be considered in subsequent years by selection committee for a fresh appointment as contractual teachers by following due procedures.
5. The teacher engaged should be address by the Principal in OAVS.

1. Regular classroom activity/ copy checking.
2. Invigilation duty/ Evaluation work.
3. Helping students and colleagues in preparation and organization of different curricular/ co-curricular activities in the vidyalaya.
