

The **ZILLA PARISHAD, RAYAGADA** on behalf of Governor of Odisha Invites **Percentage Rate Bids In Single Cover** system in conformity with detail Tender call notice No. **01/ 22-23 of Zilla Parishad, RAYAGADA** to be eventually drawn up in State P.W.D Form P-1 contract for the execution of the works detail in the table, from the class of eligible contractors as mentioned against the work in Column - 4 (four) registered with the State Governments and contractors of equivalent Grade/ Class Registered with Central Government/ MES/ Railways/ CPWD for execution of civil works. The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under State Government has to register under the appropriate registering authority of the State Government of Odisha in appropriate class of eligibility before award of the work as per prevalent registration norms of the state. The bidders may submit bids for the following works.

2. Bids must be accompanied by Earnest Money Deposit/ Bid security of the amount specified for the works and it should be submitted through on-line mode specified in tendersodisha.gov.in. No off line receipt of Tender Paper Cost and EMD will be allowed in e-procurement portal of Government of Odisha
3. Bid documents can be **Downloaded** from official website of Government of Odisha (<https://tendersodisha.gov.in/>) start from **Dt.07/ 12/ 2022 to Dt.22/12/ 2022** The bidders who have downloaded the bidding documents from the internet site will have to pay the cost of the tender document as indicated in col no. 7. The Bids will be opened on the **Dt.23/ 12/2022** at 11.00 AM in the office of the undersigned, in the presence of the members of tender committee of **Zilla Parishad, RAYAGADA**, bidders or their authorized agents who wish to attend at the Conference hall of **Zilla Parishad, RAYAGADA**. If the office happens to be closed on the last date of receipt/ opening as specified, the bids will be received / opened in the next working day at the same time and venue specified in the notification. Other details can be seen in the bidding documents.
4. Additional performance security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/ rates than the estimated cost put to tender shall have to furnish the exact amount as per table below. Additional Performance Security (APS) has to be furnished in shape of Demand Draft/ Term Deposit Receipt pledged in favour of the Block Development Officer of concern block, within seven days of issue of letter of acceptance (LOA), otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further proceeding for black listing shall be initiated against bidder.
5. In case of Engineering contractors seeking exemption of EMD are instructed to enclose an affidavit regarding the list of works awarded during the current financial year 2022-23 with exemption of EMD along with an application to avail the same for this work and will submit copy of original contract license and produce the original license at the time of opening of tender, otherwise the tender will be rejected.

6. Any bidders desirous to avail any facility as per certain circular/order of Government have to apply for the same in writing along with the tender paper. The responsibility of furnishing the copy of the circular or G.O. for allowing special facility if any shall lie on the bidder. Claim at the time of opening of tender or later stage will not be entertained.
7. If any bidder quotes less than 15% (fifteen) of the amount put to tender then such a bid shall be rejected and the tender shall be finalized basing on merit of the rest bids and if more than one bid is quoted at 14.99% (decimal upto 2 nos. will be taken for all practice purpose) less than the estimated cost, the tender accepting authority will finalize the tender through transparent lottery system in presence of bidder or their representatives.
8. The percentage quoted in the tender without mentioning excess or less shall be treated as excess.
9. Validity of tender shall be 90 days from the date of opening of tender.
10. Any addendum/ corrigendum/ cancellation of above tender will be displayed in notice Board & published in the website (<https://tendersodisha.gov.in/>)
11. after opening of the tender it is seen that, the tender has to be decided through a transparent lottery system then the lottery date will be intimated through email, Whats App no. and speed post. The lottery will be held even if no bidder remains present.


12. The authority will not be held responsible for any technical problem / failure of Network, Server during the schedule dates of online bidding .






