1. **Divisional Forest Officer, Rayagada Forest Division, Rayagada** on behalf of Governor of Odisha invites **Percentage Rates bids in (Single Cover System in online mode only)** though **e-procurement** for the construction of works as detailed in the table, from the class of eligible contractors as mentioned below registered with the State Government and Contractors of equivalent Grade/ Class Registered with other state Government/ Central Government/ MES/ CPWD/ Railways for execution of Civil Works. The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under state government, Odisha has to register under the state PWD in appropriate class of eligibility before signing of the agreement.

5. The bidder must possess compatible **Digital Signature Certificate (DSC)** of **Class-II or Class- III**.

Bids received online shall be opened at **11.00 A.M. on dated. 17.01.2023** in the office of the Divisional Forest Officer, Rayagada Forest Division, Rayagada, At./ PO./ Dist. - Rayagada, Pin: 765001, Odisha in the presence of the bidders who wish to attend. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue. And the financial bids shall be open after the Evaluation of Technical Bids.
8. The SC/ ST Contractors willing to avail the facilities as fixed by the Government will submit the scan copy of the Affidavit for the same along with tender document, otherwise they will not entitled to avail such facilities.
