The bidders may submit bids for the following works.

Bid documents consisting of Plans, specification, the schedule of quantities and the set of terms and conditions of contract and other necessary documents can be seen in the Office of the undersigned during the Office hour every day except Sunday and the public holidays till last date of sale and receipt of the Tender Papers. Interested bidder may obtain further information at the same address.

3. The sale of the Bid documents shall starts from date 03.03.2023 and closes on date 17.03.2023 during the Office hours i.e. 11.00 AM to 4.00 PM in all working days on payment of cost of bids document either in shape of cash or Demand Draft (Non-Refundable) issued from any Bank drawn in favour of the Block Development Officer, Kolnara payable at Kolnara.

4. The sealed bid documents are to be delivered through registered post/speed post only to Block Development Officer, Kolnara on or before 17.03.2023 5:00 PM. No Documents will be received after the schedule date & time. The bids received late will not be opened. The Authority will not be held responsible for the postal delay if any or non-receipt of Tender documents. The enclosure must contain the name of the work and sender's name.

The envelope must contain following documents:

- Original Receipt of the Office

- d) Attested copy of Registration Certificate

5. The Tenderers are required to submit the experience Certificate minimum one work of Tender value on Construction of building for last five years along with the Tender paper from the Competent Authority of concerned Department.

6. The bid received will be opened on 18.03.2023 at 11.00 AM in the Office of the Block Development Officer, Kolnara in the presence of bidder or there authorized agents. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time & venue.

7. Other detailed can be had in the bidding documents. The bid should be duly filled & signed by the Tenderer.

8. Special clause : Additional performance security shall be deposited by the bidder when the bid amount is on balance i.e. less than 15% of the estimated cost in such an event the bidder shall deposit the additional performance security to extend of the differential cost of bid amount & the estimated cost in shape of fixed deposit receipt of schedule bank / Kissan Vikas Patra / Post Office saving bank Account / NSC / Post Office Time Deposit Amount, duly pledged in favour of Block Development Officer, Kolnara along with the bid document failing which the bid will be summarily rejected.

09. The work should be completed within the stipulated time period of completion & in no case the time extension will be allowed except the reasons not attributable to contractors.

10. In order to ensure that, the envelopes are properly sealed, the Contractor can seal them with superglue & also add temperproof tapes as additional precaution. The Tender submitted in the wrong works shall not be taken into consideration.

11. The Authority reserves the right to reject any or all the bids without assigning any reason thereof.
