

1. The vehicle must be in Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid contract carriage permit. Proof up to date tax payment etc. Which are mandatory for applying of vehicle.
2. The Driver of the vehicle must have a valid Driving license for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The Driver should be well behaved, gentle and obedient in nature.
4. The bidders are required to execute a Bid security Declaration (at-Ann-I) in lieu of Bid security (also known as EMD) with stipulation that if they withdraw or modify their Bids during period of Validity etc. They will be suspended for one year.
5. The successful Bidder will have to deposit as security amount of Rs. 5000/- (Rupees Five Thousand) only in shape of demand draft drawn in favour of Block Development Officer, Kalyansinghpur from any Scheduled Bank as security deposit.
6. The monthly rate of hire charge be quoted separately in the general bid information (excluding POL).
7. The vehicle must achieve a fuel efficiency of (as specified above) K.Ms.per liter.

from Any scheduled bank towards the cost of application along with the application.



Annexure-II

TERMS & CONDITIONS FOR HITING OF VEHICLES


No. 518 The following terms and conditions must be fulfilled by the successful Bidder for providing a vehicle on the monthly basis. Dt. 6.3.23

1. The hired vehicles, during period of contract, shall have all necessary valid MV documents such as:- valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc, and D.L. of the driver available all the times. The department office hiring the vehicle shall not be responsible for any damage / loss caused to hired vehicles or loss of life / injury made; to any person or damage to any property on account of use of hired vehicle and manner whatsoever. The hirer shall be responsible for all such litigation.
2. The hire charges to be paid for monthly basis is final but does not include cost of diesel, which is to be paid separately basing on actual consumption and lubricants as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, Lubricating oil of engine, Gear Box & differential coolant, tyres and tubes, batter etc, will be borne by the bidder.
3. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver will be borne by the owner.
4. In case of break down for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle / bidder.
5. In case of the vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other source.
6. The vehicle shall report for duty for minimum of 25 days in a month.
7. In case of emergency, the deriver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded.
8. Monthly hire chares of selected bidder will be paid in every succeeding month, as par as possible within fifteen days of the submission of bills by the service provider and no advance payment will be made.
9. The vehicle shall not be more than 3years old from the initial registration and also in good running condition during the period of contract.
10. If the services are found to be unsatisfactory, the client shall give one moth notice and terminate the agreement.
11. In case the service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.
12. If the bidder violates any of the terms of contract, government shall forfeit the entire amount of security deposit.
13. The undersigned reserves the right to cancel or reject all or any of the offers without assigning any reasons thereof.

14. The 1st lowest bidder cannot be claimed to provide the vehicle as the vehicle will be selected by the committee with the latest model.
15. The vehicle will remain at the disposal of the Block development Officer, Kalyansingpur.
16. The selected quotationer shall have to execute and agreement with the Block development Officer , Kalyansinghpur indicating all the terms and conditions specified above.
17. The interested vehicle owners may submit quotations in sealed covers mentioning the monthly rental charges including all taxes in any and per liter consumption of diesel in KMs I the prescribed format duly super scribed "Quotation for Hiring of Vehicle.
18. The Colour of the vehicle should be White and sitting capacity of the vehicle shall not more than 5 including driver.

The quotations along with Xerox copy of PAN / IT clearance, RC Book, Road permit, fitness certificate. Insurance deposit certificate of the vehicle must reach the undersigned on or before 21.03.2023 by 5.30 P.M. The sealed quotations will be opened on 22.03.2023 at 11.00 A.M. in presence of the quotationers or their authorized representatives at office of the undersigned.

Quotations revived after the scheduled date and time shall not be entertained. The undersigned reserves the right to accept or reject any or all quotations in full or in part without assigning any reason thereof.


