The same can also be down loaded from the official website <http://rayagada.nic.in> and tender paper can be filled with a Demand Draft (D.D) of Rs.3000/-(Rupees Three Thousand) only non refundable drawn in favour of DSWO, Rayagada from any nationalized bank and payable at Rayagada towards the cost of tender papers along with EMD.



DETAILED TENDER NOTICE , TERMS AND CONDITIONS

Sealed tender in the prescribed form are invited, from the intending agency/firms having valid GST/TIN/PAN holder for supply of LPG Gas Stove with Cylinders to 880 AWCs in Six ICDS projects (B.Cuttack, Kolnara, Kashipur, Muniguda, K.Singhpur & Rayagada) of Rayagada district.

01. The tender paper must reach to the (DSWO section), Collectorate Rayagada by Registered post/speed post only on or before 29/03/23 ^(5PM) till office hour.
02. The detailed tender papers along with prescribed Tender Schedule (Annexure – I, II & III) can be obtained on payment of Rs.3000/- (Rupees Three Thousand) only (Non- refundable) from the Accounts section of D.S.W.O., Rayagada during the office hours from dt. 20.03.23 to dt. 29.03.23 on any working day. The money receipt thereof is to be submitted along with the tender forms - technical bid .The prescribed tender schedule can also be down loaded from the District website <http://rayagada.nic.in> & can be filed along with a DD of Rs.3000/- (Rupees Three Thousand) drawn in favour of DSWO, Rayagada and payable at Rayagada towards the cost of tender papers.
03. The tender will be opened at 5:00PM on dated 29/03/23 in the Collectorate, Rayagada in the presence of the tenderers or their authorized agents and members of the District Level Purchase Committee constituted.
04. The detailed terms and conditions to be collected can be inspected in the office of the DSWO, Rayagada in any working days till 29/03/23 and a soft copy may be taken by the tenderer, before filing tenders or the same can also be downloaded from the District website.
05. The sealed tender cover should super-scribed 'Supply of LPG Gas Stove with Cylinders'.
06. The intending supplier should deposit Rs.60,000/-(Rupees Sixty Thousands) only as EMD in shape of BD in favour of the DSWO, Rayagada along with the tender in Technical bid which will be kept as Security Deposit . The amount will be refunded in case of unsuccessful tenderers.
07. Earnest Money deposited by the successful tenderer will stand converted to security deposit which will be refunded after successful completion of contact period and audit of accounts of the supplier. The whole or part of the Security Deposit will be forfeited for irregular performance or breach of any term(s) and condition(s) of agreement during the period of Earnest Money.
08. The sample of the LPG Gas Stove, accessories & Cylinder to be supplied must be placed before the Tender committee and supply is to be made as per the sample presented before the Tender Committee.
09. The agency finalized for LPG Gas supply should be fully under stood the expected quality & quantity of production along with specification of the books.
10. The successful tenderers shall be required to supply the required quantity of LPG Gas stove, Cylinder with accessories at the ICDS Project Centre point within 30 days of the indent placed with the supplier.
11. The selected Agency must deliver the LPG Gas, cylinders with accessories at the project level and CDPOs will acknowledge the receipt of bill. The bill will be paid from DMF funds, Rayagada after random collection of samples from any project/projects and sent it to Competent authority for verification.
12. If the successful firm fails to execute the contract or withdraw the tender paper, the EMD of the firm will be forfeited.

13. If any deficiency to be found in the application form, the Tender application will be out right rejected.
14. The successful Tender if fails to supply the required LPG Gas stove with Cylinders during the schedule period the next highest Tenderer (L2) will be allowed to supply the same and the differential amount will be recovered from the first Tenderer (L1).
15. In case more than one tenderer quotes the same lowest rate, all the tenderers who have quoted the same lowest rates shall be called for and decision will be taken by the Tender Committee or through lottery.
16. In case of disputes about the quality, Collector or his authorized representative (s) will cause an enquiry and take suitable action including debarment against the supplier.
17. The Financial bid should be filled in properly and legible without any correction/over writing. The rate and units should be written both in words and figures and it should be serialized. The rate quoted should be final and the tenderer shall not be allowed to change the same under any circumstances.
18. Tenders received after the stipulated date and time or without sample shall be liable for rejection.
19. The Authority reserves the right to reject any or all tenders received without assigning any reason thereof.
20. The financial bids will be opened only of those renderers' whose technical bid are found eligible.
21. The tenderer has to sign in each of the tender paper as acknowledgment of acceptance of the Terms & conditions etc.
22. No Advance payment will made. After supply of all materials payment will be made only on approved item of good quality through A/C payee cheque and GST bill submission is mandatory for payments.
23. The supplier will take the responsibility to exchange the refilled Gas Cyclinder in the AWC point in a regular basis.
24. Concerned project CDPO to be responsible for collection of filled up application form, KYC and other requirement from AWWs for documentation of the new LPG connection.
25. The approximate cost break up of initial installation may submit by the intending registered Gas distributor for each AWC. Since the price of cylinders keeps varying the cost will vary accordingly, as per the price fixed by the Govt./PSU



- xiv) EMD amounting to Rs.60,000/- (Rupees Sixty thousands) only in shape of Bank Draft from any nationalized Bank favoring District Social Welfare Officer , Rayagada payable at Rayagada refundable without interest.
