CORRIGENDUM on the Contractual Appointment

In continuation to our Advertisement No.04, dated 31.03.2023 the following few modification are made considering the Govt. instructions / guidelines:-

- 1) The posts mentioned in **Sln.7** (Pharmacist RBSK), **Sln.8** (ANM RBSK), **Sln.9** (Physiotherapist at DEIC), **Sln.10** (Staff Nurse DEIC), **Sln.12** (Dental Technician at DEIC), **Sln.13** (Ophthalmic Assistant, NPCB), **Sln.14** (Optometrist) are hereby cancelled considering the Letter No.28624, dated 09.12.2020 of the H&FW Department, Govt. of Odisha and Letter No.5551, dated 05.05.2021. Hence the candidates need not apply for the same.
- 2) The **"Walk In Interview"** for the **Sln.12** (Dental Technician at DEIC), **Sln.13** (Ophthalmic Assistant, NPCB), **Sln.14** (Optometrist) proposed to held on 20.04.2023 (mentioned wrongly 20.04.2022) is hereby cancelled.
- 3) Further, the monthly remuneration mentioned in the advertisement for different posts will be based on the actual approval in the NHM PIP and it may more or less.
- 4) **Eligibility mentioned in the aforesaid advertisement against the posts may be read as under:-**

Sln.1 (BPM):- the candidate should be a Post Graduate with minimum 55% marks. S/he should have passed DCA/PGDCA or any equipvalent course from University or AICTE recognised institute / OS-CIT course of Odisha Knowledge Corporation Limited / NIELIT "O" Level.

Sln.3 (DAA):- the candidate must be a graduate in commerce with minimum 50% marks in aggregate and also must have passed DCA/PGDCA or any equipvalent course from University or AICTE recognised institute / OS-CIT course of Odisha Knowledge Corporation Limited / NIELIT "O" Level.

Sln.4 (STS):- the candidate must have bachelor degree or recognised sanitary inspector's course with minimum 50% marks in aggregate recognised university / institution and alos must have passed DCA/PGDCA or any equipvalent course from University or AICTE recognised institute / OS-CIT course of Odisha Knowledge Corporation Limited / NIELIT "O" Level.

Sln.15 (Community Nurse):- the candidate must have Master Degree in Business Administration or PG Dimploma in Business Administration or PG Dimploma in Business Management. All the above qualification from any recognised university or institution with minimum 60% marks and must have 2 (two) years duration. The candidate must have passed Odiya upto ME standard. Age Limit: 21 to 45 years.
