The 2nd District Level Committee meeting for complying the Environmental Norms in Handling & Disposal of Bio-Medical Waste including COVID-19 in respect of Rayagada district was held on 23.04.2022 under the chairmanship of Sri Saroj Kumar Mishra, OAS (SAG), Collector & District Magistrate, Rayagada on virtual mode (Google Meet).

The list of members present in the virtual meeting is enclosed as Annexure-I.


At the outset, Er P Kar, Regional Officer, SPCB, Rayagada, Member Convener of the Committee welcomed all the members and briefed about the decision taken for action in the 1st DLC meeting held on 08.04.2022.

- i. Initiating the review on action points, the Chairman asked the DPHO, Rayagada to prepare block wise list of HCFs including Clinic, Patho labs, Diagnostic Centres & Private Hospitals in coordination with concerned Medical Officers of PHC, CHC, SDH & DHH level for bringing out all the HCFs under health care licensing system to avoid any illegal operation of HCFs in the District. He also asked RO, SPCB Rayagada to enforce & sensitise all HCFs to comply with the Provisions under BMW Management Rules.
- ii. Regarding installation of CBWTF for Rayagada District, The RO, SPCB, Rayagada informed the committee that facilities can preferably be developed in a notified Industrial Area without any requirement of buffer zone as per Revised Guidelines for CBWTF of CPCB December 2016. The minimum area requirements for establishing such facilities is around 1 Ac. He opined that since IDCO Industrial Estate exist at Pitamahal in outskirts of Rayagada Town, so that area may be considered.
- iii. The Chairman instructed to initiate the process through GM, RIC, Rayagada regarding availability of IDCO land & also asked the Tahasildar, Rayagada to identify Government land of about 1 to 2 acre near to IDCO industrial Estate as alternate site for settling up CBWTF.
- iv. The Chairman asked the RO & DPHO to prepare and submit a proposal on formation of sub-committee involving SPCB Officials, Govt Medical Officers & Representative of Dist Administration so that the committee will visit entire district for close monitoring & improvement of BMW management of the District.
- v. Ms. John Mercy, Head of Nursing Dept, Christian Hospital, Bissamcuttack highlighted on problems due to the generation of huge plastic wastes from their hospital. She told that they are disposing the plastic wastes to the authorized recyclers after treatment through autoclaving.
- vi. The Chairman asked the members to prepare a strategy to make the premises of Health Care Institutions free from single use plastics for better management of BMWs.

- vii. Dr V L N Raju, DPHO Rayagada informed to the committee that the ETP proposal for the DHH Rayagada & SDH Gunupur is under active consideration at State level. The Chairman asked the DPHO to place the status of ETP in the next DLC meeting.
- viii. The Chairman instructed the Executive Officer, Rayagada Municipality for regular lifting of general solid wastes from the District Head Quarter Hospital premises to maintain better hygiene.
- ix. The chairman also asked the DPHO, Rayagada to contact the District Social Welfare Officer for selection of good NGOs either from health sectors or working in the field of Women, Child & Nutrition sector regarding IEC (Information, Education & Communication) on Waste Management among the school children as well as to get rid of single use plastic in the society.
