

Terms & Conditions

1. **Specification** : the vehicle must be of the description and specification(both physical & technical) as given in the bid document.
2. **Rate** : the cost of the item to be mentioned by the bidder shall be inclusive of all taxes as applicable , including transportation charges for at site in the office of the Executive Officer, Gunupur Municipality.
3. **Delivery of Goods** : the firm has to supply the vehicle as detailed in the bill of quantity in good condition within one month from the date of placement of order.
4. The cost of the bid documents/Tender paper is Rs.2000/- for each item which is non-refundable
5. **EMD** : EMD /Security Deposit of Rs. 10,000/- for each item in shape of Bank Draft from any Nationalised Bank in favour of Executive Officer, Gunupur Municipality payable at Gunupur should accompany with the tender paper., which will be refunded to unsuccessful bidders in due course. Bids received without EMD shall be rejected out rightly and will not be considered.
6. **Warranty**: The Vehicle should be warranted for a minimum period of 2(two) years from date of supply or as per company Norms.
7. **Inspection & Verification**: Payment will be made only after detail inspection by a Competent Officer like MVI/Mechanical Engineer at the cost of the supplier. The vehicle supplied has to be of best quality. The supplier has conduct satisfactory trail of the vehicle before receive of the same by this Municipality. He has to import detail training on use and minor maintenance of the equipments to the concerned Municipality staff which shall be mandatory before payment.
8. **Dispute**: For adjudication of any dispute between purchaser and the supplier arising in this case reference can be made to any court at Gunupur Dist-Rayagada, Odisha jurisdiction only.
9. The bidder will have to submit PAN card, up to date IT clearance, GST clearance and authorised dealership certificate which is applicable form time to time.
10. The bid documents will be available in the Municipality office and also in the website <https://rayagada.nic.in> from dt. 01.08.2018 to dt. 14.08.2018. Intending bidders can download the bid documents & send the same along with required EMD/S.D and cost of bid document in shape of DD/BD in favour of Executive Officer, Gunupur Municipality within the date line as mentioned in the Bid Document failing which, the Bid Documents shall be out rightly rejected.
