Bid documents consisting the quantities and the set of terms and conditions of contract and other necessary documents can be seen in the office of the P.A., ITDA, RAYAGADA during office hours every day except Sunday and public holidays till last date of receipt of tender documents i.e. up to 5.00 PM of 20.09.2018 Interested bidders may sought for further information if any from the same address.
3. The Bid documents consisting of the quantities of the works and the set of DTCN with terms & Conditions of contract and other necessary documents can be seen & downloaded from the RAYAGADA District website www.rayagada.nic.in from 11.00 A.M. of **19.09.2018** to **25.09.2018** up to 5.00 P.M.
4. The Collector-cum-Ex-Officio Chief Executive Officer, Special Development Council, RAYAGADA on behalf of Governor of Odisha inviting Annual Rate Contract in **OFF-LINE** mode from eligible Manufacturers/ Authorized Suppliers for supply of Musical Instruments and Costumes to 22 Nos of Tribal Dance Troupes and about 140 Nos of culture clubs run by the ST Communities to continue performing art in RAYAGADA district during the financial year 2018-19 under Special Development Council Funds. The approximate requirement of quantity and the type of costume and musical instruments for 22 different tribal dance group will be as per the list enclosed herewith separately at Annexure-I. Like-wise, 162 (22+140) sets of costumes and musical instruments will be required for different tribal dance group, which may vary basing on the actual requirement at the time of placing of orders. The bidders are required to quote their rate in the enclosed Financial Bid (Annexure-II) separately for each group in the said Format.

The bid documents are available in the RAYAGADA District Official website of NIC www.rayagada.nic.in and can be downloaded from 11.00 A.M. of Dt-19.09.2018 to 5.00 P.M. of Dt-25.09.2018. The last date and time of receipt of Bid as per D.T.C.N data through Registered Post/ Speed Post only is up to 5.00 PM of 25.09.2018. The authority will not be held responsible for Postal delay if any or non-receipt of the tender documents by the date line.

MUSICAL INSTRUMENTS & COSTUMES:

The musical instruments and costumes as per list at Annexure-I should be of good quality. Priority will be given to the bidders considering the quality of materials and price quoted thereof. Approximately 162 (22+140) sets of costume and musical instruments for 20 different tribal dance groups will be required. The requirement may exceed or decrease depending on the actual requirement and orders will be placed accordingly from time to time during the period of Annual Rate Contract. **The bidders are required to quote their rate item-wise/unit-wise in the enclosed prescribed Format of Financial Bid separately for each group at Annexures.**

Manufacturer/Supplier/Proprietor:

1. A person, group, or company that owns or runs a manufacturing plant.
2. A person, group, or company that manufactures/ Authorized Supplier.

1. Eligibility Criteria:

- 1.1 All manufacturers/ Suppliers/ Proprietors dealing with supply of musical instruments and costumes for triabals.
- 1.2 Preference shall be given to the manufactures/ Suppliers/ Proprietors of RAYAGADA district.
- 1.3 The Supplier should have valid Income Tax(PAN)/VAT Registration Certificate.
- 1.4 The Financial Bid (Annexure-II) should also be accompanied with the tender document.

1.5 All the terms & conditions of DTCN must be fulfilled by the bidders and the required amount towards Cost of Tender Paper & EMD must be submitted in shape of Demand Draft along with tender documents.

2. **Scope of work:**

2.1 The broad scope of the work would be design, supply and transportation of musical instruments and costumes for tribals to blocks/ Registered Club/ Community Centre point by whom Supply Order are to be placed.

2.2 The block-wise requirement of the musical instruments and costumes of tribals will be provided along with the supplies order.

2.3 A clear understanding on the supply to the assigned Registered Club/ Community Centre under RAYAGADA district is available with the PA, ITDA RAYAGADA, which can be enquired through his contact number mentioned in the FACT Sheet, which requires a prior discussion.

2.4 Storage facility of the items to be supplied should be provided by the Supplier for inspection at intermediate points for facilitating the process.

2.5 The Agencies shall have to supply the items to the Registered Club/ Community Centre as per the work order. Intended Suppliers are advised to collect all necessary information beforehand about approach road to the village, distance and mode of transportation etc., before submitting the Annual Rate Contract.

2.6 Proper storage of musical instruments and costumes shall be the responsibility of the Suppliers. The name of Registered Club/ Community Centre will be provided with the work order. In some cases, actual number of items to be supplied may vary to some extent, hence suppliers are required to seek confirmation in this regard from PA, ITDA RAYAGADA prior to dispatch of musical instruments and costumes.

2.7 After supply of the musical instruments/ costumes to the Registered Club/ Community Centre in the specific locations as per instruction of the District Cultural Officer/ Concerned PA, ITDAs/Authorized Officer, the Suppliers shall obtain acknowledgement from the concerned Registered Club/ Community Centre about receiving the musical instrument/ costumes in good condition.

2.8 The date of issue of Supply Order shall be reckoned as the date of commencement of supply.

2.9 All necessary conditions as further outlined in the subsequent sections of this document are to be followed.

3. **Instructions to Bidders:**

3.1 Bidders must submit their bid through proper means.

3.2 Bid must be submitted in English language only.

3.3 Incomplete, telegraphic or conditional bids shall not be accepted.

- 3.4 Prices quoted must be firm and fixed. No price variation / escalation shall be allowed.
- 3.5 The bidders/ authorized Agent must sign at the bottom of each page of the bid documents at the time of submission in token of unconditional acceptance of the departmental terms and conditions, technical specifications etc.
- 3.6 Copy of IT returns Statement / Valid GSTN/Copy of PAN card etc. duly attested must be submitted along with the bid.
- 3.7 Deviations in terms and conditions, Inspection clause etc. would not be accepted under normal conditions. However, under exceptional situation the same may be considered at the discretion of authority.
- 3.8 The quantity of materials to be purchased are subject to alteration without any notice.
- 3.9 Since timely supply of materials are of paramount importance, requests for extension of time shall not be entertained.
- 3.10 Canvassing in any manner shall not be entertained and will be viewed seriously leading to rejection of the bid.
- 3.11 All essential supplementing documents should be signed in case of need for verification, originals should be produced.
- 3.12 Earnest money/ Tender Paper Cost must be deposited in shape of Demand Draft to be drawn in favour of the **Project Administrator, ITDA, RAYAGADA** payable at **RAYAGADA** from any Scheduled Bank. **Bids without E.M.D and Bid Cost will be rejected.**
- 3.13 **The last date of receipt of the bid through OFF-LINE mode i.e. by Registered Post/ Speed Post (Post Office only) is up to 5.00 P.M. of 25.09.2018, after which if any tender documents to be received will be rejected.**
- 3.14 **The bid documents received in OFF-LINE mode through Registered Post/ Speed Posts by the date line shall be opened on 27.09.2018 at 11.00 AM** in the Collectorate, RAYAGADA in presence of the bidders or their authorized representatives, who may like to be present at the time of opening.
- 3.15 The bidders during supply of the materials are required to fix with logo of Special Development Council to be supplied by ITDA, RAYAGADA to the selected suppliers, after the tender is finalized.
- 3.16 Power of attorney to sign the agreement on behalf of bidders & partnership deed articles, if any, should be enclosed along with original bid documents.
- 3.17 Notice inviting tender, bid documents, prescribed price bid, terms & conditions will form the part of the tender.
- 3.18 In case of supply of any defective material or substandard material, the materials will be rejected & it will be the responsibility of the supplier for taking back & replacing the rejected materials at their own cost. In case of non-lifting of such rejected

materials within a reasonable time offered by the office, it will have the right to suitably dispose of the same and forfeit the amount.

- 3.19 The supplied materials should be strictly complied with the specifications as mentioned in the bid/supply order, otherwise the material would be liable for rejection.
- 3.20 Bidders may in their own interest visit the sites or undertake field enquiry of the proposed places before submitting bids. SDC, RAYAGADA will not be responsible for any incidental or consequential losses of the firms during supply of materials.
- 3.21 All bids received will remain valid for a period (90 days) as specified in the Contract Data after the deadline date for submission of bids and validity of bids can also be extended if agreed to by the bidder and the Department.

(4) **Procedure for opening of Tender:**

(A) The procedure of opening of the bid shall be as under

- i) The Bid documents along with Financial Bid shall be opened by the Tender Committee as per the date, time and venue mentioned in the "Tender Call Notice & DTCN", in presence of tenderers who choose to be present. The financial suitability of offers will be examined in detail considering documents submitted by the Supplier also.
- ii) All bidders shall essentially quote their rate in the Financial Bid Format (Annexure-II).

(5) **Acceptance/ Rejection of the bid documents:**

Collector-cum-Ex-Officio Chief Executive Officer, Special Development Council, RAYAGADA reserves the right to;

- i) Reject or accept any or all bids without assigning any reason thereof.
- ii) To split the quantities against the bid on more than one firm for the same items.
- iii) Alter or delete any of the terms and conditions mentioned in this bid documents during the process of tender till finalization, for which, No reason will be assigned by SDC for this and the same will be binding on the bidders.

6. **Earnest Money Deposit:**

6.1 The earnest money deposited (EMD) is to be paid through Demand Draft issued from any Scheduled Bank in favour of the Project Administrator ITDA RAYAGADA and should be enclosed with the bid documents..

6.2 Unsuccessful Bidder's EMD will be discharged/ returned as promptly as possible within thirty (30) days after the issuance of work order to successful bidder.

The bid security may be forfeited:

a) if a Bidder :

- (i) Withdraws its bid during the period of bid validity specified by the Bidder on the Bid Form.
- (ii) in case a successful Bidder fails to sign the Contract within the specified period.

7. Payment Terms:

Payment under normal circumstances will be done as detailed below;

- i) The Payment will be released after supply of the intended materials in good condition, on production of necessary bills/ vouchers in this regard by the Supplier. The Suppliers are also required to furnish a certificate to that effect regarding handing over of the materials.

8. TERMS & CONDITIONS:

(a) The Bid documents shall be submitted by Registered Post/ Speed post only in the address of **Project Administrator ITDA RAYAGADA, At/Po-RAYAGADA, District- RAYAGADA, PIN- 765001, Odisha**. Conditional tenders and tenders without EMD shall be rejected.

(b) The Rates quoted should be on the basis of destinations anywhere in RAYAGADA district. Prices to be quoted in Financial Bid will be with all applicable taxes. The Quoted rates shall be valid for one year from the date of opening of tender as this is Annual Rate Contract.

9. The bidders from RAYAGADA district should be given priority during finalization of tender.

10. ITDA, RAYAGADA/ Special Development Council, RAYAGADA reserves the right to split the work order on the lowest quoted rates to one or more than one qualified bidders other than Lowest-1 for early supply of materials or any other reasons, if requires. The decision of SDC, RAYAGADA regarding quantity will be final and binding on selected bidders in this case.

11. The material shall be supplied at the specified site after confirming from the District Culture Officer/ Concerned PA, ITDAs.

12. The work order(s) shall be placed depending upon the requirement of the agency from time to time within the validity period of tender.

13. All disputes relating to this work shall be subject to the jurisdiction of RAYAGADA district headquarters and Collector, RAYAGADA shall be the sole arbitrator.
