2. **Rate:** The cost of the item to be mentioned by the quotationer shall be inclusive of all taxes as applicable, including packing & forwarding charges, loading & unloading charge, transportation charges for at site in the O/O the Executive Officer, Gunupur Municipality.
3. **Door Delivery of goods:** The firm has to supply the goods within 7 days from the date of placement of order.
4. **Inspection and Verification:** Payment will be made only after detail inspection of quality and commissioning of ATM. The materials supplied has to be of best quality.
5. **Dispute:** For adjudication of any dispute between purchaser & the supplier arising in this case, reference can be made to any court at Gunupur only.
6. The bidder will have to submit PAN card, up to date IT clearance, GST clearance and authorised dealership certificate which is applicable form time to time.
