## Tender Call Notice for Hiring of Vehicle

Sealed Tenders are invited from interested reputed travel agencies / Tour Operator or Private individuals for providing non A/C Hired Vehicle having sitting capacity not more than five including driver on Call Basis for official use in ICDS Office (Mission Shakti Project) Padmapur Block. The details of Tender Document including General information may be referred from the district website, [www.rayagada.nic.in](http://www.rayagada.nic.in).

1. The Vehicle must be road worthy condition, shall not be more than 3 years old from the date of registration and must of valid Registration Certificate, Insurance Certificate, Fitness Certificate, etc which are mandatory for running of vehicle.
2. The driver of the vehicle must have a valid Driving license for driving light transport passenger vehicle and should be sufficient experience in driving.
3. The driver should be well behaved, gentle & obedient in nature.
4. A sum of Rs.2000/- (Rupees Two Thousand Only) shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the CDPO, Mission Shakti, Padmapur as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
5. The monthly rate of the hire charges is quoted separately in the general bid information including fuel and lubricants.
6. The monthly rate of the hire charge is Rs. 10,000/- for 10 days on call basis & the Vehicle must move within the project area.
7. The vehicle must achieve a fuel efficiency of 12 KMs per litter.
8. The details of the months & year of manufacture of the vehicle, Registration number, Name of the Driver & DL number and period of validity should be specifically provided in the general bid information to be furnished with the Quotation / Tender (Annexure-III).
9. The quotation completed in all respect should reach to the undersigned by Speed Post/ Regd. Post/ By hand Only on or before 04/09/2019 at 5 PM and shall be opened on 05/09/2019 at 5 PM in presence of the bidders or their authorized representatives.
10. The payment of hire charge shall be made on monthly basis after submission of bill.
11. Salary of the driver will be paid by the vehicle owner and all repairs will be borne by the owner.
12. Local bidders as given the first preference.
13. The undersigned reserves the right to cancel or reject any or all the quotation / tenders without assigning and reason at any point of time, same will be published in the Dist. Website.
