The Block Development Officer, Rayagada on behalf of Governor of Odisha invites percentage rates bids for the Construction of works as detailed below in the Table from ELIGIBLE Contractors registered with the State Govt. and Contractors of equivalent Grade/Class registered with Central Govt. for execution of Civil works on production of definite proof from the appropriate Authority which agreement is to be drawn in P1 form. Bids document consisting of Plans, specification, the schedule of quantities and the set of terms and conditions of contract and other necessary documents can be seen in the office undersigned during the office hour every day except Sunday and the public holiday till last date of sale and receipt of the Tender Papers. The Sale and Receipt of the Bid documents shall starts from Dt. 22.04.2021 and close on 30.04.2021 during the Office hours i.e. 07.00 AM to 1.00 PM (Except Sunday and Holiday) on payment of cost of bids document either in shape of cash or Demand Draft (Non-Refundable) issued from any Nationalized Bank drawn in favour of the Block Development Officer, Rayagada payable at Rayagada.

The sealed bid documents are to be delivered in the Tender box having identification No. B.D.O, Rayagada-01 and shall contain signed DTCN attested copy of Registration Certificate, PAN Card, valid GSTIN Certificate, document, Valid Labour License affidavit regarding authentication of documents, no relation certificate, document required as per the relevant clauses of the DTCN and special condition if any required amount of EMD in shape of NSC/KVP/POTD/Bank deposit receipt of any Nationalized Bank deposit receipt of any Nationalized Bank duly pledged in favour of Block Development Officer, Rayagada without which bid will not be considered. The Tender can also send their Tender Papers through Registered Post/Speed Post only to Block Development Office, Rayagada such bids must be received on or before stipulated date & time as mentioned above. The bids received late will not be opened. The authority will not be held responsible for the postal delay if any or non-receipt of Tender documents. The bidders are not required to write their name on the outer cover of the bid but they require to writing the name of work with name of Office from which bid document was issued.

The Engineering contractor desires of having EMD exemption benefit must have to produce an affidavit to the effect that, they have not availed such exemption for more than three times during this financial year. Also the engineering contractor will produce his/her Original license at the time of opening of Tender so that the Tender opening authority will enter the exemption of EMD in his/her license falling which Tender liable for rejection.
6. The Tenders are required to submit the experience Certificate minimum one work of Tender value on Construction of building for last five years along with the Tender paper from the competent authority of concern department.
7. The bid received will be opened on 03.05.2021 at 10.00AM in the Office of the Block Development Officer Rayagada in the presence of bidder or there authorized agents with to attend. If the office happens to be closed on the date or receipt/opening of the bids as specified, the bids will be received/ opened on the next working day at the same time & venue.
8. Other detailed can be had in the bidding documents. The bid should be duly filled & signed by the Tenderer.
9. Special clause : Additional performance security shall be deposited by the bidder when the bid amount is on balance i.e. less than 15% of the estimated cost in such an event the bidder shall deposit the additional performance security to extend of the differential cost of bid amount & the estimated cost in shape of fixed deposit receipt of schedule bank/Kissan Vikas Patra/ Post Office saving bank Account/ N.S.C/ Post office Time Deposit Amount, dully pledged in favour of Block Development Office, Rayagada along with the bid document failing which the bid will be summarily rejected.
10. The authority reserves the right to reject any or all the bids without assigning any reason thereof.
11. The work should be completed within the stipulated time period of completion & in no case the time extension will be allowed except the reasons not attributable to contractors.
12. In Order to ensure that the envelopes are properly sealed, the contractor can seal them with superglue & also add tamperproof tapes as additional precaution. The Tender submitted in the wrong works shall not be taken in to consideration.
