5. The riser pipes will be sold to the bidder on the above rate as per actual weightage of the materials at the weighing machine point in presence of the authorized officer of this office. (to be disposed separately). Empty truck will be weighted first, then loaded truck will be weighed to ascertain actual weight of the materials.
6. The highest bidder or eligible bidder should deposit the total amount of the Auction sale price before lifting of the materials (In shape of Cash/DD).
