The Superintending Engineer, RWS&S Division, Rayagada on behalf of the Governor of Odisha invites tender through e-procurement in conformity with the terms and conditions of the Detailed Tender Call Notice ( DTCN) in Single cover system from the established Firm/Registered Contractors of "D & C Class" of State PWD or equivalent class of CPWD/Railway/MES/Central Government & State Government fulfilling the minimum eligibility criteria as stated here under and other detailed qualifying requirements given in the DTCN on "PERCENTAGE RATE BASIS" for the following works to be eventually drawn up in the standard P<sub>1</sub> contract form. The bid should be uploaded on-line in the website [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) by the eligible class of contractors. The bidders should have the necessary Portal Enrolment (with his own Digital Signature Certificate). The registered bidders of outside Odisha can also participate in this process, after necessary Portal Enrolment, but shall have to subsequently undergo registration with the appropriate authority of the State Government within a month of acceptance of the bid.
