**AUCTION SALE NOTICE**


Sealed tender/ quotation are hereby invited from interested bidders for auction sale of one condemned office vehicle bearing Registration No. OR-18-4444 (Armada) of the Special Land Acquisition Officer, Rayagada on "AS IS WHERE IS BASIS". The offset price of the condemned vehicle have been fixed at Rs.41,000/- (Rupees Forty One Thousand) only.

The intending parties/ bidders may inspect the vehicle in the premises of Collectorate, Rayagada on any working days from 10.30 AM to 05.00 PM. **Last date for submission of the bid is 27.07.2022 by 05.30 PM. The bid shall be submitted to the Collector, Rayagada in the enclosed format through Regd. Post/ Speed Post only.** The envelope containing the bid shall be super scribed on the top "**Sealed quotations/ tenders for Auction Sale of the condemned Government Vehicles**". Bids received beyond the last date/ time shall not be accepted. **The bids will be opened on 28.07.2022 at 11.00 AM in the Chintan Kakshya, Collectorate, Rayagada.** Bidders or any of their authorized representatives can remain present at the time of opening the bids.

**Terms and Conditions:-**

1. The competitors shall be required to pay earnest money deposit amounting to **Rs.1,000/- (Rupees One Thousand) only** in shape of **Accounts Payee Bank Draft** on any nationalized bank in favour of the **Collector, Rayagada** and submit it along with the bid. After completion of bidding process, the earnest money deposit will be refunded to the unsuccessful bidders and in case of successful bidders the same shall be adjusted against the sale price of the vehicle.
2. The highest offer above the upset price fixed shall be accepted and confirmed. The purchaser is liable to pay GST along with cess as per applicable rate, on the bid amount.
3. The highest bidder shall deposit 25% of the bid amount as initial deposit immediately after the bid is confirmed and the rest within 7 days from the date of confirmation of the bid failing which 25% of the quoted value as initial deposit along with earnest money deposit will be forfeited. The 25% of the bid amount and the earnest money deposited are subject to adjustment at the time of final payment of the quoted value.
4. The vehicle shall not be delivered to the successful bidder until he/ she makes full payment and comply with all requisite formalities. Tools, implements and spare parts if any, shall not be delivered with the vehicle.


5. The bidder shall remove the vehicle from the site within 7 days from the date of depositing the full amount of bid/ tendered money along with applicable tax & cess after getting permission from the undersigned. Custody or safeguard of the vehicle shall be the responsibility of the bidder after the bid is confirmed and no claim or complaint on that account shall be admissible.
6. On failure to remove the vehicle within stipulated time as aforesaid, ground rent @1% of the bid/ tendered money shall be charged for each day or part of the day till removal of the vehicle from the site.
7. Where the ground rent so charged exceeds the sale price deposited, the bidder shall cease to have any right on the vehicle. The amount deposited by him/ her shall be adjusted towards the ground rent and the vehicle shall become absolute property of the Government and disposed of by fresh auction or tender as the case may be.
8. The undersigned reserve the right to accept or reject the auction sale without assigning any reason thereof.


