1. The **Project Administrator, ITDA, Gunupur** on behalf of Governor of Odisha invites **Percentage Rate bids** through **online mode** in **Double Cover System** for the works as detailed in the table, from the class of eligible contractors as mentioned in column-6 (six) registered with the State Government and Contractors of equivalent Grade / Class Registered with Central Government / MES / Railways for execution of Civil Works. The bidders should have the necessary Portal Enrolment (with his own Digital Signature Certificate). The registered bidders outside Odisha, can also participate in this process, after necessary Portal enrolment, but shall have to subsequently undergo registration with the appropriate authority of the State Government before award of the work. The bid should be submitted only online on the website www.tendersodisha.gov.in.

1. Bid documents consisting of plans, specifications, the schedule of quantities and the set of terms & Conditions of contract and other necessary Documents can be seen in the website www.tendersodisha.gov.in
2. For broader participation of bidders due to present situation of pandemic "EMD" is exempted for submission of Bid Security during Tendering/ Bidding. Further, in lieu of Bid Security (EMD), bidders to sign "Bid Security

Declaration" accepting that if they withdraw or modify their bids during period of validity etc., they will be suspended for the time specified in the tender documents as per Office Memorandum No. 8943/Fin-COD-MISC-0007-2019 Dated 18.03.2021 of Finance Department, Govt. of Odisha. The undertaking for Bid security declaration certificate is attached as **ANNEXURA- A** in the DTCN for the time being.

3. Now, the successful bidder has to deposit 1% of EMD of the bid amount at the time of execution of Agreement in pursuant to O.M.No. 5992/W Dated 27.04.2021 in shape of FDR/ TDR/ Bank Guarantee pledged in favour of the PA, ITDA, Gunupur.
4. Engineer Contractor up to "C - Class" desirous to avail the facility of exemption of E.M.D is required to submit an affidavit to the effect that he has not yet availed the facility / participated in the tender for more than two works (Excluding this work) during the current financial year. The name of work for which participated and the authority to whom the tender was submitted must be mentioned in the affidavit, failing which the tender will be rejected. Also he should submit the original engineering license at the time of opening of tender for recording of exemption of EMD with due verification of previous exemption, availed if any.
5. The Bid documents will be available in the website www.tendersodisha.gov.in from **10.00 A.M of 21.9.2022 to 5.30 P.M of 6.10.2022** for online bidding.
6. The Bidder must possess **Compatible Digital Signature Certificate (DSC) of Class II or Class III**. Bids shall be received only "On-line" on or before **5.30 P.M of 06.10.2022**
7. Bids received "on-line" shall be **opened at 11.00 A.M on 12.10.2022** in the office of the PA, ITDA, Gunupur, Odisha in presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
8. Demand draft towards cost of bid document & other documents shall be submitted in the office of the undersigned from **of 10.00 A.M of 07.10.2022 to 11.10.2022 Up to 5.30 P.M** during office hours on working days directly through **tender box kept at ITDA office / Registered Post** within the schedule time mentioned above, failing which the bid will be rejected and **if any bidder participated on the online bidding process and has not withdrawn before closing date and fails to deposit cost of bid as above will be liable for action as per clause No. -2 of e-procurement portal.**
9. The cost of bid document has to be paid by each bidder in shape of Demand Draft drawn in favour of **PA, ITDA, Gunupur** from any nationalized scheduled bank (mentioned in **Column 8** of above table) payable at **Gunupur** towards cost of bid.
10. The bidder shall scan all the written pages of the bid security and up load the same to the system in designated place. The online bidder shall submit the 'bid security Declaration' in lieu of bid security during submission of Original documents within the specified period mentioned in the DTCN (after receipt date of bid but before opening date & time of bid) with the "Officer inviting the Bid". The Officer inviting the bid shall not be responsible for any postal delay and/or non- receipt of the original copy of the bid security on or before specified date and time. Non-submission of Bid Security declaration & demand draft towards cost of bid document within the stipulated period shall be debarred the bidder from participating in the on-line bidding system and his portal registration shall be cancelled. His name shall also be informed to the registering authority for cancellation of his registration.
11. The bid must have accompanied with Check list (online & offline) as prescribed in the DTCN & submitted with original documents for necessary verification during scrutiny of documents.
12. Additional performance Security shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. in such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as Additional Performance Security (APS) in shape of Demand Draft/Term Deposit Receipt /Bank Guarantee pledged in favour of the PA, ITDA, Gunupur within seven days, otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for blacklisting shall be initiated against bidder. The State Govt. is pleased to fix the following rate of Additional Performance Security vide Office Memorandum No. 4559/W Dated 05.04.2021 of Works Department, Govt. of Odisha.

15. The Amount put to tender is exclusive of GST. The intending Bidders should offer their rates which shall be exclusive of GST applicable as per norms. GST as applicable on works contract shall be paid over the bill amount at the time of payment of Bill.
16. If the rate quoted by any bidder is less by 15% or more than the estimated cost put to tender than such bid(s) shall be rejected.
17. The contractor has to upload an Affidavit regarding correctness of all the document uploaded in the website and also required to submit all relevant documents to the procurement officer such as Original affidavits for authentication, SC/ST price preference / Exemption of EMD for Engineering Contractor.
18. Authority will not be held responsible for system failure, malfunction of internet or traffic jam. Bidders are advised to submit their bids well in advance within the stipulated period.
19. In the event of the specified date of bid opening being declared a holiday/ or any technical error, the bids will be opened at the appointed time on the next working day.
20. The companies or individuals registered with State Government and contractors of equivalent Grade / Class registered with Central Government / MES / Railways having registration for Civil, Electrical and P.H. works having both legal competency and expertise in Civil, Public Health and Electrical Engineering works need put tenders for this composite work and the documentary evidence under appropriate Act in support of their legal competency and expertise to execute Civil, Electrical and P.H. work invariably should accompany their tender papers. The Civil Contractor in order to take part in the Composite tender should enter into a sub-contract agreement with eligible Registered P.H.Plumber & Electrician (**Associate with the contractor**) and affidavit in this regard should be attached with the Tender in original and this shall also form a part of the tender.
21. **Exemption of EMD:** The Engineering contractors desirous of availing exemption from EMD should abide by the norms as contained in No. FA-Codes-6/2011-600/W dtd. 18.01.2011 as furnished in DTCN.
22. The documents must contain (**Cover-I**) in 1) Technical document & 2) Financial Documents for this work separately to be drop in the Tender Box.
 - 1) **Technical documents to be submitted in a separate cover** – Affidavit, No relation Certificate, Certificate of Tools & Plants, List of Work Experience of similar nature of works if any. Registration Certificate, Valid License, PAN (**Up to date Income Tax Clearance certificate**), Active GST (**Up to date Valid GSTIN**), Caste Certificate & other requisite documents as called for in the DTCN. **On the body of the cover to be written as Technical Document.**
 - 2) **Financial documents to be submitted in a separate cover :** **Bid Security declaration, Paper Cost (OFF LINE)**
On the body of the cover to be written as Financial Document.
 - 3) In a double cover system the Technical bid (online) will be opened first & after Technical evaluation by the Tender Committee the Financial bid (**Cover-II**) in online mode will be opened only of successful bidder. Both Technical Document Cover & Financial document cover (Bid Securing Declaration & Paper cost) to be incorporated in a Big cover mentioning the name of Tender Work by the bidder..
23. Other details can be seen in the bid documents. Subsequent Corrigendum (if any) can be only seen in the web site www.tendersodisha.gov.in
24. The authority reserves right to cancel any or all bids without assigning any reason thereof.

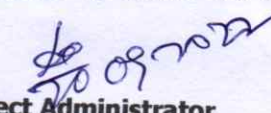
