Bids must be accompanied by Earnest Money Deposit/ Bid Security of the amount specified for the work in the **col. 5** of table above, pledged in favour of **PA, ITDA, Rayagada** and will have to be in any one of the forms as specified in the bidding documents. Bidders desirous to hire machineries or equipments from outside the State or owned but deployed outside the state are required to furnish 1% of the amount put to tender as Bid Security.
4. Engineer Contractor desirous to avail the facility of exemption of E.M.D is required to submit an affidavit to the effect that he has not yet availed the facility / participated in the tender for more than two works (Excluding this work) during the current financial year. The name of work for which participated and the authority to whom the tender was submitted must be mentioned in the affidavit, failing which the tender will be rejected. Also he should submit the original engineering license at the time of opening of tender for recording of exemption of EMD with due verification of previous exemption, availed if any.
5. Now, the successful bidder has to deposit 1% of EMD of the bid amount at the time of execution of Agreement in pursuant to O.M.No. 5992/W Dated 27.04.2021 in shape of FDR/ TDR/ Bank Guarantee pledged in favour of the PA, ITDA, Rayagada
6. **Exemption of EMD-** Engineer Contractor up to “C- Class” desirous to avail the facility of exemption of E.M.D should abide by the norms as contained in No. FA-Codes-6/2011-600/W dtd. 18.01.2011 as furnished in DTCN & is required to submit an affidavit to the effect that he has not yet availed the facility / participated in the tender for more than two works (Excluding this work) during the current financial year. The name of work for which participated and the authority to whom the tender was submitted must be mentioned in the affidavit, failing which the tender will be rejected. Also he should submit the original engineering license at the time of opening of tender for recording of exemption of EMD with due verification of previous exemption, availed if any.

8. The Bidder must possess **Compatible Digital Signature Certificate (DSC) of Class II or Class III.**
9. Bids shall be received only “On-line” on or before **5.00 P.M of 06.11.2023**
10. Bids received “on-line” shall be **opened at 11.00 A.M on 08.11.2023** in the office of the PA, ITDA, Rayagada, Odisha in presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
11. Original Bid Security (EMD) & Demand draft towards Cost of Bid document (offline) & Affidavits in original shall be submitted in the office of the undersigned from **of 10.00 A.M of 17.10.2023 to 07.11.2023 Up to 5.00 P.M** during office hours on working days directly through **Registered Post** within the schedule time mentioned above, failing which the bid will be rejected and **if any bidder participated on the online bidding process and if he/she has not submitted on or before dated 07-11-2023 and fails to deposit Cost of Bid and EMD through Offline mode as above will be liable for action as per clause No. -2 of e-procurement portal.**

12. The Cost of Bid document has to be paid by each bidder as mentioned under *Column 06* in shape of Demand Draft drawn in favour of PA, ITDA, Rayagada from any nationalized scheduled bank (mentioned in *column 6* of above table) payable at Rayagada towards Cost of Bid.
13. *The Bidder shall furnish, as part of his Bid, a Bid security for each work separately as per the amount mentioned under Col. 5 of NIT/Contract Data. The bidder shall scan all the written pages of the bid security and up load the same to the system in designated place. The online bidder shall deposit the original copy of the 'Bid Security' within the specified period mentioned in the DTCN (after receipt date of bid but before opening date & time of bid) with the "Officer inviting the Bid". The Officer inviting the bid shall not be responsible for any postal delay and/or non- receipt of the original copy of the bid security on or before specified date and time. The bid Security (EMD) in shape of N.S.C./ Post Office Savings Bank Account/ Post Office Time Deposit Account/ Kisan Vikas Patra./ Bank Guarantee in favour of the PA, ITDA, Rayagada from any Nationalized Scheduled Bank in India counter guaranteed by its local Branch at Rayagada / e-Bank Guarantee executed on the National e- Governance Services Limited (NeSL) Digital Document Execution Portal towards E.M.D/initial Security Deposit/ any other security deposit from the bidder."*
14. *Additional performance Security shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. in such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as Additional Performance Security (ApS) in shape of Demand Draft/Term Deposit Receipt /Bank Guarantee pledged in favour of the PA, ITDA, Rayagada within seven days, otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for blacklisting shall be initiated against bidder. The State Govt. is pleased to fix the following rate of Additional Performance Security vide Office Memorandum No. 4559/W Dated 05.04.2021 of Works Department, Govt. of Odisha.*

15. The Amount put to tender is exclusive of GST. The intending Bidders should offer their rates which shall be exclusive of GST applicable as per norms. GST as applicable on works contract shall be paid over the bill amount at the time of payment of Bill.
16. If the rate quoted by any bidder is less by 15% or more than the estimated cost put to tender than such bid(s) shall be rejected.
17. The contractor has to upload an Affidavit regarding correctness of all the document uploaded in the website and also required to submit all relevant documents to the procurement officer such as Original affidavits for authentication, SC/ST price preference / Exemption of EMD for Engineering Contractor.
18. Authority will not be held responsible for system failure, malfunction of internet or traffic jam. Bidders are advised to submit their bids well in advance within the stipulated period.
19. In the event of the specified date of bid opening being declared a holiday or any technical error, the bids will be opened at the appointed time on the next working day.
20. The companies or individuals registered with State Government and contractors of equivalent Grade / class registered with Central Government / MES / Railways having registration for Civil, Electrical and P.H. works, if any having both legal competency and expertise in Civil, Public Health and Electrical Engineering works need put tenders for this composite work and the documentary evidence under appropriate Act in support of their legal competency and expertise to execute Civil, Electrical and P.H. work if any invariably should accompany their tender papers.*(Not Mandatory)*
