

Silviculturist, Silviculture Division, Rayagada on behalf of Governor of Odisha invites percentage bids in Single Cover in online mode for the construction works as detailed in the table below, from the class of eligible contractors as mentioned in column - 6 (Six) registered with the State Government and contractors of equivalent grade / class registered with Central Government / MES / Railways for execution of civil works. The proof of registration from the appropriate authority shall be enclosed along with the bid. If successful the bidder who has not registered under the State Government has to register under the appropriate registering authority of the State Government of Odisha in appropriate class of eligibility before award of the work.

4. The bidder must possess compatible Digital Signature Certificate (DSC) of Class-II & Class-III

5. Bids shall be received only 'Online' on or before dt. 26.10.2023 up to 5.00 PM.
6. Bids received on line shall be opened at 11.00 AM on dt. 27.10.2023 in the office of the Silviculturist, Silviculture Division, Rayagada in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of sale and receipt of the bids as specified, the bids will be opened on the next working day at the same time and venue.
7. The bidder shall transfer online the cost of Bid document for Rs.6000/- towards cost of the Bid through a process as mentioned under DTCN.
8. Tenders complete in all respect should be uploaded with valid registration Certificate, PAN Card, Active GST Certificate, T.P. Cost, Affidavit in Schedule-F & Schedule-E, Bid-declaration form and other required documents in the prescribed format.
9. This is a time-bound work, to be completed within the stipulated period. The respective bidders are advised to study the scope of work and survey the site for constraints if any and assess their bid capacity and capability before submitting their tenders.

The authority reserves the right to reject any or all tenders without assigning any reason thereof.


