## SCOPE OF WORK AND INSTRUCTIONS FOR BIDDERS

01. Govt. in Science and Technology Department, Govt. of Odisha has established one standalone Planetarium in Kadambariguda, PS-Chandili, Dist- Rayagada. For general operation and maintenance of the centre, Watch & ward, Gardening and land scaping, Sweeping and Housekeeping, office support staff and technical person (electrical).will be outsourced from the Service Providers
02. The contract for providing the aforesaid manpower shall continue at the above location for a period of one year from the date of commencement of service. The period of the contract may be further extended for a further period of another one year provided the requirement of the offices for manpower persists at that time. The period of contract may be curtailed /terminated before completion of one year owing to deficiency in service or substandard quality of manpower deployed by the selected Service Provider or because of change in the office requirements. The Collector-cum-Chairman, ZBPS, Rayagada, however, reserves the right to terminate the initial contract at any time after giving 15 days' notice to the selected Service Provider. **Under no circumstances the manpower/personnel shall be allowed to continue for more than a period of two years, so as to avoid future litigation relating to regularization.**
03. The Group-D/Technician manpower shall be engaged as Watch & ward, Gardening and land scaping, Sweeping and Housekeeping, office support staff and technical person (electrical) in Nagavali Standalone Planetarium, Rayagada.
04. The estimated cost of the contract is Rs. 12,99,600/- (Rupees Twelve Laks Ninety Nine thousand Six hundred) only per annum excluding applicable taxes, statutory dues and negotiated service charges. As desired by authority additional man power may be engaged on the same terms & conditions based on requirement . Similarly , man power may be curtailed as per decision of authority.
05. The interested Service Providers shall submit the tender document complete in all respects along with other requisite documents by 18.03.2024, at 5.00 P.M. at the Office of the District Education Officer, Rayagada by Registered post / speed post for the purpose.
06. The various crucial dates relating to "Tender for Providing Services of Group-D/Technician post for the Nagavali Standalone Planetarium" are cited as above (Page:4 of this tender document).

07. The tender has been invited under two bid systems i.e. Technical Bid annexed at **Annexure - I** and Financial Bid annexed at **Annexure - III**. The interested bidders are required to submit the bids in two separate sealed envelopes super scribing "Technical Bid for Providing Services of Group-D/Technician personnel for Nagavali Standalone Planetarium" and "Financial Bid for Providing Services of Group-D personnel to Nagavali Standalone Planetarium ". Both sealed envelopes should be kept in a third sealed envelope super scribing "**Tender for Providing Services of Group-D personnel for the Nagavali Standalone Planetarium "** in shape of the address superscribed as **DISTRICT EDUCATION OFFICE, RAYAGADA**
08. All bidders will have to deposit a Non-refundable payment of Rs.2000/- (Two Thousand) only as the cost of Tender Paper in shape of Demand Draft of any Nationalized Bank drawn in favour of District Education Officer, Rayagada payable at Rayagada along with the Technical Bid.
09. As per the FDOM No.4939 dated 13.02.2012 all bidders will have to deposit a Bid Security of **Rs.25,992/- (Rupees Twenty Five Thousand Nine hundred Ninety Two only)** in the form of Bank Guarantee / Term Deposit Receipt (TDR) from any Nationalized Bank drawn / pledged in favour of District Education Officer, Rayagada payable at Rayagada covering the period of contract along with the Technical Bid. The Bid Security Deposit will be returned to the unsuccessful bidders after selection of the successful bidder . The successful bidder will have to deposit a Performance Security Deposit of Rs.64,980/- (Rupees Sixty Four Thousand Nine hundred Eighty only) (being 5% of the cost of the contract) in the shape of Bank Guarantee/ Term Deposit Receipt (TOR) from any Nationalized Bank drawn in favour of District Education Officer, Rayagada covering the period of contract. The successful bidder may deposit the balance amount after deducting the bid security deposited.
10. The interested Manpower Service Providers are required to enclose the Self attested documents as mentioned in Annexure-V along with the Technical Bid, failing which their Bids shall be summarily/out rightly rejected and will not be considered.
11. The conditional bids shall not be considered and will be out rightly rejected.
12. All entries in the tender form should be legible and filled clearly. If the space for furnishing information is insufficient, a separate sheet duly signed by the authorized signatory may be attached. No overwriting or cutting is permitted in the Financial Bid Form. In such cases, the tender shall be summarily rejected.

13. The Technical Bids shall be opened on the scheduled date and time i.e. **21.03.2024 at 3.00pm** in presence of the Selection Committee and the Authorized representatives of the Manpower Service Providers, if any, who wish to be present on the spot at the time of opening of the Bids.
14. The; Financial bids shall be opened on the scheduled date and time on **21.03.2024 at 4.00 p.m** in the Chintana Kakhya, Collectorate, Rayagada in presence of the Selection Committee and the representatives of the Manpower Service Providers, if any, who wish to be present on the spot at the time of opening of the Bids.
15. The Selection Committee can use its own discretion for selection of the service provider; the decision taken by the Committee shall be final.
16. The Chairman-cum-Collector and District Magistrate, Rayagada reserves the right to reject any or all bids without assigning any reason.



**TECHNICAL REQUIREMENTS FOR THE TENDERING MAN POWER  
SERVICE PROVIDER**

The tendering manpower service provider agencies should fulfill the following technical specifications:

- (a) The registered office of the manpower service provider agency should be located within the State of Odisha.
- (b) The agency should have been registered with the appropriate registering authority.
- (c) The agency should have at least "three years" experience in providing manpower **particularly Group-D personnel**.
- (d) The agency should have own Bank Account.
- (e) The agency should be registered with Income Tax and Service Tax (GST) department.
- (f) The agency should be registered with appropriate authorities under Employees Provident Fund and Employees State Insurance Acts.
- (g) The agency should have any other regulatory clearance (to be specified by the user Department) that may be required for providing man power services.
- (h) The agency should have minimum average annual turn-over of Rs. 01 (One) Crore during the financial year 2020-21,2021-22& 2022-23 in providing man power services.
- (i) The agency should have executed contracts of similar type during preceding 3 (three) years i.e. for the financial year 2020-21, 2021-22 & 2022-23.
- (j) The agency should not have any criminal antecedent/ previous unsatisfactory service report/ previously black listed by any organization.

**TECHNICAL REQUIREMENTS FOR MANPOWER TO BE DEPLOYED  
BY THE SUCCESSFUL MANPOWER SERVICE PROVIDER IN  
NAGAVALI STANDALONE PLANETARIUM, KADAMBARIGUDA,

1. The Group-D/Technician personnel should be above 18 years and not more than 50 years of age.
2. The minimum educational qualification of Security person and Support staff must be 10<sup>th</sup> pass. For electrician, the applicant must have qualified in ITI (Electrical) from any recognized institution having experience of two years.
3. They may have experience in sweeping, cleaning, dusting, gardening, marketing, etc. The applicant must be in good physical health condition and to be vigilant during the silent hours. Lack of knowledge of the above-mentioned works will lead to their immediate disengagement.
4. They must not have any criminal antecedent. Each Group D personnel/Technician, at the time of his engagement, shall furnish a self-declaration of not having any criminal antecedent duly verified and certified by the Agency to the Authority.

1. The total rates quoted by the Service Provider should be inclusive of all statutory / tax liabilities in force at the time of entering into contract.
2. The payment shall be made on conclusion of the calendar month only on the basis of number of working days for which duty has been performed by each manpower.
3. The minimum service charge shall be 3.85% ( 3 % profit plus transaction charges provided that the service charges should not exceed 7% in any case).

TERMS AND CONDITIONS**GENERAL**

1. The Agreement shall be valid for one year unless it is curtailed or terminated by the authority owing to deficiency of service, sub-standard quality of manpower deployed, breach of contract etc. or change in requirements.
2. The Agreement shall automatically expire after completion of one year unless extended further by the mutual consent of the Manpower Service Provider and Authority.
3. The Agreement may be extended, on the same terms and conditions or with some additions/ deletions/ modifications, for a further specific period mutually agreed upon by the Man Power Service Provider and Authority. However, **under no circumstances the manpower/ personnel engaged shall be allowed to continue for more than two years, so as to avoid future litigation relating to regularization.**
4. The Man Power Service Provider shall not be allowed to transfer, assign, pledge or sub contract its rights and liabilities under this agreement to any other agency or organizations by whatever name be called without the prior written consent of the Authority ..
5. The Manpower Service Provider will be bound by the details furnished by into the Authority while submitting the tender or at subsequent stage. In case, any of such documents furnished is found to be false at any stage, it would be deemed to be a breach of terms of Agreement making it liable for legal action besides termination of the agreement and forfeiture of performance Security. Action as deemed proper shall be initiated against the Service Provider Agency .
6. The Authority reserves the right to terminate the agreement at any time during the period of contract after giving 15 days' notice to the Man Power Service Provider.
7. The persons deployed in the Centre besides normal working hours will be called on holidays to attend duty if required in case of urgency. They are entitled for special leave as per FDOM No. 30794 dated 06.11.2021.
8. The Manpower Service Provider shall nominate a coordinator who shall be responsible for immediate interaction with the office of the District Education Officer, Rayagada so that optimal services of the persons deployed could be availed without any disruption.
9. The entire financial liability in respect of man power services deployed in the Planetarium Centre shall be that of the Man power Service Provider and Collector-cum-Chairperson, ZBPS will no way be liable. It will be the responsibility of the Man power Service Provider to pay to the person deployed a sum not less than the minimum rate quoted in the financial bid and produce such evidence as may be required by the Collector-cum-Chairperson, ZBPS, Rayagada.



10. For all intents and purposes, the Manpower Service Provider shall be the "Employer" within the meaning of different Rules & Acts in respect of man power so deployed. The persons deployed by the Manpower Service Provider shall not have any claim whatsoever like employer and employee relationship against Collector-cum-Chairperson, ZBPS Rayagada.
11. The Manpower Service Provider shall be solely responsible for the redressal of grievances or resolution of disputes relating to persons deployed. Collector-cum-Chairperson, ZBPS Rayagada shall, in no way, be responsible for settlement of such issues whatsoever.
12. The Collector-cum-Chairperson, ZBPS Rayagada shall not be responsible for any financial loss or any injury to any person deployed by the Manpower Service Provider in the course of their performing the functions/duties, or for payment towards any compensation.
13. The persons deployed by the Manpower Service Provider shall not claim nor shall be entitled to pay, perks and other facilities admissible to regular/confirmed employees during or after expiry of the Agreement.
14. In case of termination of this agreement on its expiry or otherwise, the persons deployed by the Manpower Service Provider shall not be entitled to and shall have no claim for any absorption in regular or other capacity.
15. The person deployed shall not claim any benefit or compensation or absorption or regularization of deployment with office. Undertaking from the person deployed to this effect shall be required to be submitted by the Man Power Service Provider at the time of commencement of such deployment.
16. The Manpower Service Provider must be registered with the concerned Govt. Authorities i.e. Labour Commissioner, Provident Fund Authorities, Employees State Insurance Corporation etc. and a copy of the registration should be submitted. The Manpower Service Provider shall comply with all the legal requirements for obtaining License under Contract Labour (Regulations and Abolition) Act, 1970 if any, at his own part and cost.
17. The Manpower Service Provider shall provide a substitute well in advance if there occurs any probability of the person leaving the job due to his own personal reasons. The payment in respect of the overlapping period of the substitute shall be the responsibility of the Man power Service Provider. The Manpower Service Provider shall be responsible for contributions towards Provident Fund and Employees State Insurance, wherever applicable.
18. The persons deployed by the Manpower Service Provider should have good police records and no criminal case should be pending against them. Police verification of the antecedents of the deployed personnel can be made at the discretion of the Collector-cum-Chairperson, ZBPS Rayagada.
19. The persons deployed should be polite, cordial and efficient while handling the assigned work and their actions should promote good will and enhance the image of the office.
20. The agency must not have been blacklisted by any Central / State Government any other public sector undertaking or any authority during the recent past. An undertaking to this effect shall be furnished by the Bidders as per the prescribed format at FORM T2.

## **LEGAL**

1. The persons deployed shall not commit any mischief in any form with the case records, documents, registers and files. In view of this, they shall be required to maintain confidentiality and breach of this condition shall make the Manpower Service Provider as well as the person deployed liable for penal action under the applicable laws besides, action for breach of contract.
2. The Manpower Service Provider shall be responsible for compliance of all statutory provisions to minimum wages payable to different types of workers in respect of the persons deployed by it in the Nagavali Standalone Planetarium Rayagada. The Collector-cum- Chairperson, ZBPS, RAYAGADA shall have no liability in this regard.
3. The Manpower Service Provider shall also be liable for depositing all taxes, levies, Chess, etc., on account of service rendered by it to the concerned tax collection authorities, from time to time, as per the Rules and Regulations in the matter. Attested Xerox copies of such documents shall be furnished to the Collector-cum- Chairperson, ZBPS, RAYAGADA as and when required.
4. The Manpower Service Provider shall maintain all statutory registers under the law and shall produce the same, on demand, to the Collector-cum- Chairperson, ZBPS, RAYAGADA or any other authority under law.
5. The Tax Deduction at Source (TDS) shall be done as per the provisions of Income Tax Act/ Rules, GST Act/ Rules, as amended, from time to time and a certificate to this effect shall be provided by Collector-cum- Chairperson, ZBPS, RAYAGADA
6. In case the Manpower Service Provider fails to comply with any liability under appropriate law and as a result thereof, the Collector-cum- Chairperson, ZBPS, RAYAGADA is put to any loss/obligation, monetary or otherwise, the Collector-cum- Chairperson, ZBPS, RAYAGADA will be entitled to get itself reimbursed out of the outstanding bills or the Performance Security Deposit of the Manpower Service Provider, to the extent of the loss or obligation in monetary terms.
7. The Agreement is liable to be terminated because of non-performance, deviation of terms and conditions of contract, non-payment of remuneration of employed persons and non-payment of statutory dues. The Collector-cum- Chairperson, ZBPS, RAYAGADA will have no liability towards non-payment of remuneration to the persons employed by the Manpower Service Provider and the outstanding statutory dues of the service provider to statutory authorities . If any loss or damage is caused to the Collector-cum- Chairperson, ZBPS, RAYAGADA by the person deployed, the same shall be recovered from the unpaid bills or adjusted from the Performance Security Deposit.

1.
