TERMS AND CONDITIONS

- 1. The appointment is purely temporary and terminable at any time without notice and without assigning any reasons thereof.
- 2. The candidates should join in their place of posting within 15 days from the date of receipt of this order failing which the appointment order in respect of the concerned candidate shall stand automatically cancelled.
- 3. The concerned Candidates will be on probation period of two years from the date of their joining in the post, during or at the end of the said probation period, if they are found unfair to continue further, their services shall be terminated.
- 4. The appointment shall be entitled to leave under the provisions of the Odisha Leave Rules, 1966 and shall abide by the Odisha Civil Services Conduct Rules 1959 and subject to the Odisha Civil Services (clarification, Control and Appeal) Rules 1962.
- 5. The appointee will be enrolled under the new pension Scheme contained in the Odisha Civil Services amended (Pension) Rules 1992 from the date of his/ her Joining.
- 6. Scheduled Caste/ Scheduled Tribe/ SEBC/ Physically Handicapped certificate, if any, from the competent authority should be produced for verification at the time of their joining. They are liable to termination if their Caste/ Physically Handicapped is proved to be false later.
- 7. They should produce a medical certificate as required under Rule 49 read with rule 50 of the Odisha Service Code at the time of joining.
- 8. Two character certificates from two Gazetted Officers not below the rank of Group-B Officers should be produced.
- 9. A declaration to the effect that no criminal antecedent/ case is pending against him/ her.(Original)
- 10. A declaration to the effect that he/ she is having not more than one spouse living, if married, should be produced.
- 11.H.S.C Certificate in original should be produced for verification of Date of Birth.
- 12.A declaration regarding his/ her age be submitted before the authority where she/ he joined.
- 13. Two recent colour pass port size photograph should be produced at the time of joining.
