Sealed Quotations are invited from interested reputed Travel Agencies/Tour Operators or Private individuals for providing 01(One) no. of AC BS-IV Diesel driven TUV 300/Bolero/Sumo Gold Vehicle having sitting capacity not more than 7 including driver, which shall conform to the Terms and conditions(Annexure-II) for official use in this office ICDS Project , PADMAPUR on monthly rent basis:

1. The Vehicle must be in Road Worthy condition shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate Insurance Certificate, Valid Contact Carriage permit, Proof of up to date tax payment ect. Which are mandatory for-plying of vehicle.
2. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The Driver should be well behaved, gentle, and obedient in nature.
4. The monthly rate of Maximum hire charges is limited to Rs.31000/-(Rupees Thirty one Thousand) only (excluding fuel cost for 60Lits) be quoted separately in the general bid information.
5. A sum of Rs.5000/- shall be deposited by the in intending Bidders in shape of Account Payee Bank Draft Drawn in favour of the CDPO, PADMAPUR and submitted along with the Tender has security deposit after completion of Tender Process, the amount will be refunded to Unsuccessful Bidders.
6. The Vehicle must achieve a fuel efficiency of 10 kms per liter.

ANNEXURE-I

TERMS & CONDITIONS FOR HIRING OF VEHICLES

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.

1. The hired vehicles, during period of contract, shall have all necessary valid MV documents such as valid Registration Certificate, insurance Certificate, Fitness Certificate, Valid Contract Carriage permit, proof of up to date tax payment etc. and D.L of the driver available all the times. The office hiring the vehicle shall not be responsible for any person or damages to any property on account of use of hired vehicle any manner whatsoever. The hirer shall be responsible for all such litigation.
2. The hire charges to be paid for monthly basis is final but does not include cost of diesel, which is to be paid separately basing on actual consumption of the vehicle towards repair, replacement of spare parts, Lubricating oil of Engine, Gear Box & differential Coolant, Tyres & Tubes, Battery etc, Will be borne by the bidder.
3. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.
4. In case of breakdown for reasons whatever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle /bidder.
5. In case of the vehicle do not report regularly, the authority will be liberty to reject the agreement and may engage vehicle from other source.
6. In case of emergency, the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded.
7. Monthly hire charges (as per Govt.norms) of selected bidder will be paid in every succeeding month, as far as possible within fifteen days of the submission of bills by the service provide and advance payment will be made.
8. The vehicle shall not be more than 3 years old from the initial registration and also in good running condition during the period of contract.
9. If the services are found to be unsatisfactory, the client shall give one month notice and terminate the agreement.
10. In case the service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.
11. If the bidder violates any of the terms of contract. Government shall forfeit the entire amount of security deposit.
