OFFICE ORDER

Seema Smaraki Ray and Manash Kumar Naik are hereby temporarily engaged as Aspirational Block Fellow with monthly stipend of Rs. 55000/- (Rupees Fifty-Five Thousand only).

Terms & Condition

1. The Appointment is purely temporary and terminable at any time without notice and without assigning any reasons thereof.
2. The candidates should join in their place of posting within 7 days from the date of receipt of their order failing which the appointment order in respect of the concerned candidate shall stand automatically cancelled.
3. They should produce a medical certificate as required under Rule 49 read with rule 50 of the Odisha Service Code at the time of joining.
4. Two character certificates from two gazetted officers not below the rank of Group-B Officers should be produced.
5. A declaration to the effect that no criminal antecedent/case is pending against him/her.(Original).
6. A declaration to the effect that he/she is having not more than one spouse living, if married, should be produced.
7. H.S.C certificate for verification of Date of Birth and essential qualifications & all other original academic certificates/experience certificates with two attested copies each in original should be produced during the time of joining.
8. A declaration regarding his/her age be submitted before the authority where she/he shall be joined.
9. Two recent colour pass port size photograph should be produced at the time of joining.
10. Suppression of correct information or furnishing of false information in application shall render the appointee liable for disengagement in addition to other legal action.
11. No TA will be allowed to join in the present place of posting.
12. The tenure of Aspirational Block Fellow will initially be up to October-2024. Further contingent upon the satisfactory performance of AB Fellow and demonstrated contribution to the program's objectives as determined by the State Govt., the program may allow for an extension of one-year of the fellowship.
13. During the time of his/her joining, an agreement is to be signed in a non-judicial stamp paper with CDO-cum-EO, Zila Parishad Rayagada.
