The Block **Development Officer, Panchayat Samiti, Gunupur** on behalf of Governor of Odisha invites **percentage Rate bids in online mode** for the Additional Classroom Building Works as detailed in the table, from the class of eligible contractors as mentioned in column-5 (five) registered with the State Governments and contractors of Equivalent Grade / Class Registered with Central Government / MES / Railways for execution of Civil works. The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under state government, Orissa has to register under the state PWD in appropriate class of eligibility before signing of the agreement.
2. Bid documents consisting of qualification information and eligible criteria of bidders, specifications, drawings, schedule of quantities and the set of terms & conditions of contract and other necessary documents can be seen in the website: [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in).
3. The bidder shall deposit the EMD/Bid Security amount specified for the work in the col. 6 of Annexure table above as part of bid through a process as mentioned in the DTCN.
4. The Bid documents will be available in the website: [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) from 10.00 Hours of 26.05.2025 to 17.00 Hours of 09.06.2025 for online bidding.
5. The Bidders must possess **Compatible Digital Signature Certificate (DSC)**.
6. Bids shall be received on or before 17.00 Hours of 09.06.2025.
7. The bid shall be opened at 11.00 Hours on 10.06.2025 in the office chamber of the **Block Development Officer, Panchayata Samiti, Gunupur (District-Rayagada, Odisha)** in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If it happens to be a holiday on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
8. The cost of bid documents has to be paid separately towards cost of each bid respectively.
9. The Engineering contractors have to submit their license / registration certificate in the office of the undersigned on or before 10.00 Hours of 10.06.2025 during office hours on working days for necessary entry failing which the bid will not be considered for availing exempted of EMD.
10. The SC/ST Contractors have to specifically apply in writing for availing price preference otherwise they cannot avail the same.
11. As the GST is in force since 01.07.2017, the intending bidder should offer their rates which shall be exclusive of GST applicable as per norms. GST as applicable on works contract shall be paid over the bill amount at the time of payment of bill.
