The Sub-Collector-cum-Chairman, R.M.C., Rayagada on behalf of R.M.C., Rayagada invites sealed RFQ from reputed expert agencies / companies to submit a proposal for complete engineering (Supplied and procurement materials and supervision fabrication, erection, testing, pre commissioning and commissioning for complete repair of 500 MT weigh bridge situated at Lekapai Sub-Market Yard of R.M.C., Rayagada in Kolnara Block.

An amount of Rs. 5,000/- (Rupees Five Thousand only) non refundable towards the cost of RFQ document have to be enclosed in shape of demand draft drawn an any National Bank payable in favour of Secretary, R.M.C., Rayagada payable at Rayagada.

The agencies / companies must furnish documents tabulated below.

1. GST / PAN Certificate
2. Bank Draft towards cost tender documents.
3. Statement of performance last 3 years along with documentary evidence
4. Revenue Certificate
5. List of Service centres
6. Certificate recognizing technology by the Govt of India.
7. The Quotationer should quote the rate of spare parts which is to be used in the Weigh Bridge inclusive labour and transport & other charges.
8. The Quotationer has to quote the service charges to make the weigh bridge in working condition.
9. The repairing work should be completed within 7 days receipt of the work order.
10. Complete repair should be taken and warranty period provided. The bidder shall bear all cost of repair if required during warranty period.
11. The intended bidder may inspect the site from 10.00 AM to 1.00 PM from 7.11.2025 to 17.11.2025 except in Govt. Holidays. After carefully observation submit the sealed tender paper
12. Separate sealed tender paper should be submitted for Financial Bid.

The proposal should be submitted to the Secretary, R.M.C., Rayagada through Speed Post / Registered Post / Drop in the Drop Box available in the office premises by 18.11.2025 till 5.00 PM

The Technical bid will be open on 20.11.2025 at 3.00 PM. If possible in the presence of bidders who choose to attend.

The Technical Bid shall be evaluated jointly by the Committee. After open of Financial Bid for L-1 bidder will be selected.

The agencies shall be sole responsible for any cost they may insure for a site visit transport / postage etc. in the process of submission of proposal.
