1. The Project Administrator, ITDA, Rayagada invites Percentage Rate bids (Double and Single Cover System in online mode only) for the construction of works from the class of eligible contractors registered with the State Government and Contractors of equivalent Grade / Class Registered with Central Government / MES / Railways for execution of Civil Works as mentioned in column-4 (Four) in the table given below. The contractors should have the necessary Portal Enrolment (with his own Digital Signature Certificate). The registered contractors/bidders outside Odisha, can also participate in this process, after necessary Portal enrolment, but he/she will have to subsequently undergo registration with the appropriate authority of the State Government before award of the work. The contractors should submit the bid in online mode only on the website www.tendersodisha.gov.in.

2. Bid documents consisting of plans, specifications, the schedule of quantities and the set of terms & Conditions of contract and other necessary Documents can be seen in the website www.tendersodisha.gov.in
3. Bids must be accompanied by Earnest Money Deposit/ Bid Security of the amount specified for the work in the col. 5 of table above, pledged in favour of **PA, ITDA, Rayagada** and will have to be in any one of the forms as specified in the bidding documents. Bidders desirous to hire machineries or equipments from outside the State or owned but deployed outside the state are required to furnish 1% of the amount put to tender as Bid Security.
4. Engineer Contractor desirous to avail the facility of exemption of E.M.D is required to submit an affidavit to the effect that he has not yet availed the facility / participated in the tender for more than two works (Excluding this work) during the current financial year. The name of work for which participated and the authority to whom the tender was submitted must be mentioned in the affidavit, failing which the tender will be rejected. Also he shall submit the original engineering license at the time of opening of tender for recording of exemption of EMD with due verification of previous exemption, availed if any.



5. Now, the successful bidder has to deposit 1% of EMD of the bid amount at the time of execution of Agreement in pursuant to O.M.No. 5992/W Dated 27.04.2021 in shape of Post Office N.S.C/K.V.P/Term Deposit Account /Bank Guarantee pledged in favour of the PA, ITDA, Rayagada
6. **Exemption of EMD-** Engineer Contractor up to “C- Class” desirous to avail the facility of exemption of E.M.D should abide by the norms as contained in No. FA-Codes-6/2011-600/W dtd. 18.01.2011 as furnished in DTCN & is required to submit an affidavit to the effect that he has not yet availed the facility / participated in the tender for more than two works (Excluding this work) during the current financial year. The name of work for which participated and the authority to whom the tender was submitted must be mentioned in the affidavit, failing which the tender will be rejected. Also he should submit the original engineering license at the time of opening of tender for recording of exemption of EMD with due verification of previous exemption, availed if any.
7. The Bid documents will be available in the website www.tendersodisha.gov.in from 10.00 A.M of 24.11.2025 to 5.00 P.M of 05.12.2025 for online bidding.
8. The Bidder must possess **Compatible Digital Signature Certificate (DSC) of Class II or Class III.**
9. Bids shall be received only “On-line” on or before 5.00 P.M of 05.12.2025
10. Bids received “on-line” shall be opened at 11.00 A.M on 08.12.2025 in the office of the PA, ITDA, Rayagada, Odisha in presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
11. The bidders have to submit cost of Tender Paper (**Column No.6**) & Bid Security (**Column No.5**) amount through online in favour of the Tender inviting Authority i.e. Project Administrator, ITDA, Rayagada .
Procedures of bid submission using electronic payment of tender paper cost and EMD by bidder:
 - a) Log on to e-Procurement Portal: The bidders have to log onto the Odisha e- Procurement portal (<https://tendersodisha.gov.in>) using his/her digital signature certificate and then search and then select the required active tender from the 'Search Active Tender" option. Now, submit button can be clicked against the selected tender so that it comes to the “Tenders" section.
 - b) Uploading of Prequalification/Technical/Financial bid: The bidders have to upload the required Prequalification /Technical/Financial bid, as mentioned in the bidding document and in line with Works Department office memorandum no.7885, dt 23 07 2013.

c) Electronic payment of tender paper cost including GST/EMD/ Additional Performance Security: Then the bidders have to select and submit the bank name as available in the payment options.

i. A bidder shall make electronic payment using his/her internet banking enabled account with designated Banks or their aggregator banks.

ii. A bidder having account in other Banks can make payment using NEFT/RTGS facility of designated Banks.

Online NEFT/RTGS payment using internet banking of the bank in which the bidder holds his account, by adding the account number as mentioned in the challan as an interbank beneficiary.

d) Bid submission: Only after receipt of intimation at the e-Procurement portal regarding successful transaction by bidder the system will activate the 'Freeze Bid Submission' button to conclude the bid submission process.

e) System generated acknowledgement receipt for successful bid submission:

System will generate an acknowledgement receipt for successful bid submission. The bidder should make a note of 'Bid ID' generated in the acknowledgement receipt for tracking their bid status.

12. *Additional performance Security shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. in such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as Additional Performance Security (ApS) in shape of Post Office N.S.C/K.V.P/Term Deposit Account /Bank Guarantee pledged in favour of the PA, ITDA, Rayagada within seven days, otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for blacklisting shall be initiated against bidder. The State Govt. is pleased to fix the following rate of Additional Performance Security vide Office Memorandum No. 4559/W Dated 05.04.2021 of Works Department, Govt. of Odisha.*

13. The Amount put to tender is exclusive of GST. The intending Bidders should offer their rates which shall be exclusive of GST applicable as per norms. GST as applicable on works contract shall be paid over the bill amount at the time of payment of Bill.
14. If the rate quoted by any bidder is less by 15% or more than the estimated cost put to tender than such bid(s) shall be rejected.

15. The contractor has to upload an Affidavit regarding correctness of all the documents in the website from 10.00 A.M of 24.11.2025 to 05.12.2025 up to 5.00 P.M within the schedule time mentioned above, failing which the bid will be rejected.
16. Authority will not be held responsible for system failure, malfunction of internet or traffic jam. Bidders are advised to submit their bids well in advance within the stipulated period.
17. In the event of the specified date of bid opening being declared a holiday or any technical error, the bids will be opened at the appointed time on the next working day.
18. The companies or individuals registered with State Government and contractors of equivalent Grade / class registered with Central Government / MES / Railways having registration for Civil, Electrical and P.H. works, if any having both legal competency and expertise in Civil, Public Health and Electrical Engineering works need put tenders for this composite work and the documentary evidence under appropriate Act in support of their legal competency and expertise to execute Civil, Electrical and P.H. work if any invariably should accompany their tender papers.(*Not Mandatory*)
19. **To avail the 50% exemption of EMD and Price Preference :** The intending SC/ST contractors should upload the scan copy of the caste certificate for exemption of 50% EMD & also upload the copy of application for availing price preference. The attested copy of the certificate and the said application should be submitted to the authority of i.e. PA, ITDA, Rayagada on or before the date and time of the opening of the tender.
