



3. Satisfactory work done certificate from previously completed works of installation of Solar Street lights and High Mast Lights in other Blocks/ ITDAs of Odisha from the Head of office to be submitted.
4. Warranty period should be minimum 05 years: Repairing & maintenance should be at the spot.
5. The quotationer should submit two no of bid form 1. Technical bid 2. Financial bid in different two cover and submit the same in one cover with name mentioned as quotation call notice no.380, and date: 07.02.2026, addressing Block Development Officer, RAMNAGUDA
6. The bidders who have secured a minimum of 20 points in the technical evaluation shall be declared technically qualified and will be eligible for opening of their financial bids.
7. The rate quoted should be inclusive of all taxes plus supplying, fitting, fixing, transportation cost & other levies to the destination.
8. A sum of Rs.5000/- (Rupees One thousand) only towards advertisement cost in shape of Bank Draft only in favour of B.D.O, RAMNAGUDA, District Rayagada payable at any nationalised Bank, RAMNAGUDA and must be attached with the quotation paper.
9. On all the matters relating to this quotation call documents, the decision of the Purchase Committee shall be final and binding and the same cannot be referred to the court of law. The Panchayat Samiti reserves the right to reject any or all the quotations without assigning any reason what so ever.

- The company shall submit LED and battery pack data sheet along with ISO certificate.
- The company should have sufficient technical staff for compliance of any complaints regarding nonfunctional lights as and when required.
- The company should have accidental insurance for the staff involved in installing the said lights in case of any accident occurring during the process of installation; the tendered shall not be responsible.
- The company shall have its own production house.
- The farm/company should have its own solar street lights test report from NABL accredited lab.
- The company should have its own registered service center in Rayagada and should not be less than one year.
- The Company should have sufficient number of technical staff not less than 8Nos and all should have accidental insurance for the staff involved in installation activities.
