


- The remaining six bidders were deemed qualified for the opening of the Technical Bid.




Upon reviewing the Financial Bids in relation to the suggested specifications, it was found that the lowest two bidders did not meet the required specification as per tender Notice.

- g) **Others:** Laptop Bag
- h) **Accessories:** Wireless keyboard and mouse combo

2. The quoted price must be inclusive of GST, delivery, installation, and demonstration at the Tahasil Office, Kashipur.




