


TERMS AND CONDITIONS

1. The sealed tenders be received by Registered post / Courier service only (No hand delivery is permitted).the tender paper will not be acceptable after due date and time. The bidder must super scribe on the sealed cover as "Quotation for auction of fruits of Chingudijhar farm, Kasipur / HDPO, Bhakurguda Farm , Rayagada.
2. Tender must accompany EMD (earnest money deposit) in shape of demand draft drawn in favour of the Dy. Director of Horticulture, Rayagada payable at SBI, Rayagada . The DD amount shall be adjusted towards the sale value of the successful bidders and in all other cases shall be returned to the parties concerned, after conclusion of sale process.
3. Sale shall be confirmed by the DDH only after the full amount along with security money is deposited. Security money to the tune of 10% of the sale value shall be deposited by the party in shape of SB account opened by him in his name in any Nationalized Bank and pledged in favour of the DDH, Rayagada . The Security money shall be released after the working period is over.
4. The sealed tenders received in due date & time shall be opened in the offices specified in the tender call notice in presence of the parties or their authorized representatives by an auction committee as per the scheduled mentioned in the tender call notice.
5. The highest bidder should deposit the sale value in full on the same day, the failure of which will entail for forfeiture of his EMD and on the event the other tenderers shall be considered one after the other in decreasing order of their bid provided their offer is more than the upset price and is acceptable otherwise.
6. In case the offer does not reach the upset price, then the committee shall negotiate with the parties present same day to decide the sale. If the negotiation fails then the items has to be put to tender following due procedure. If the Offer still remains below upset price , then the sale has to be decided through above negotiation process same day.
7. The work order shall be issued by the ADH /AHO concerned only after confirmation of the sale by the DDH,Rayagada .
8. All appeal in the matter of any dispute shall lie only with the Director of Horticulture, Orissa Bhubaneswar whose decision shall be final and binding on all parities.
9. Before issue of work order an agreement shall be executed by the ADH / AHO concerned with successful tenderer incorporating all terms and condition of sale in a standard format to be approved by the DDH,Rayagada.
10. The authority is not responsible for any damage or shortfall due to natural calamities like cyclone/ hail storm and theft etc. The operational period of the tender will be over by 16th June 2026.
11. The intending parities may visit the orchard on any working day of the farm between any working hours after obtaining necessary permission from concerned Farm-in-charge , before submission of the quotation.
12. The farm In-Charge reserves the right to collect the scion material from the mother plants auctioned during the lease period
13. The successful bidder has to furnish an undertaking to the effect that there will be no injury or damage to the existing plants and other plants also. He is liable to give compensation if any injury or damage. Compensation is to be fixed by the In-charge of the farms / AHO / ADH concerned and the final decision of the undersigned. The successful bidders shall be allowed to harvest the specified blocks.
14. The money receipt in original shall be attached with the tender paper.
15. The record on total quantity harvested by the auction is to be mentioned by the farm-in-charge.
16. The authority reserves the right to reject any or all the quotations without assigning any reason thereof.


