



TERMS AND CONDITIONS

1. Sealed quotations from intending bidders will be received by registered post/courier service by the undersigned on or before 27.04.2026 up to 11.00 AM. No hand delivery is permitted. Late tenders will not be accepted. The sealed cover must be super scribed as "QUOTATION FOR AUCTION SALE OF MANGO OF EMRS,Siriguda,Rayagada" .
2. Quotation must be accompanied by Earnest Money Deposit (EMD) in the form of Demand Draft/Banker's Cheque drawn in favour of Principal ,EMRS,Siriguda, Rayagada payable at SBI Station bazar Branch, Rayagada. Quotations without EMD will be rejected. The EMD of unsuccessful bidders will be refunded after completion of the process.
3. The sealed quotations received within the due date will be opened as per schedule in the presence of the auction committee and bidders (or their representatives) at the office of the Principal,EMRS, Siriguda, Rayagada 28.04.2026 at 9.00 AM.
4. Sale will be confirmed only after full payment along with security deposit is realized. Security deposit of 10% of sale value must be deposited in cash on the same day. It will be released after the harvesting period (after July 2026).
5. The highest bidder must deposit the full sale value on the same day, failing which the EMD will be forfeited. Other bidders may be considered in decreasing order if their bid is acceptable.
6. The Farm In-charge/ Principal ,EMRS, Siriguda, Rayagada will issue the work order only after confirmation of sale.
7. Any dispute shall be settled by the Principal, EMRS, Siriguda, Rayagada, whose decision will be final and binding.
8. Before issuing the work order, an agreement shall be executed by the Farm In-charge with the successful bidder including all terms and conditions approved by the Principal ,EMRS, Siriguda, Rayagada.
9. The authority is not responsible for any loss or damage due to natural calamities or any other reason.
10. Interested bidders may inspect the farm on any working day between 9 AM to 5 PM with prior permission of the Farm In-charge.
11. The highest bidder must give an undertaking not to damage any plants during harvesting. Any damage caused must be compensated as decided by the authority. The decision of Principal EMRS, Siriguda, Rayagada final.
12. The original money receipt for purchase of tender paper must be attached with the tender document.
13. The authority reserves the right to reject any or all quotations without assigning any reason.
14. The successful bidder must maintain records of total harvested quantity and submit it to the concerned authority.
15. EMD amount is Rs. 1000/-(One Thousand Only).
16. If the quoted bid value is lower than the upset price, the committee may negotiate with the bidders.
17. The working period will be decided by the Principal , EMRS,Siriguda, Rayagada and will be final.
